Downhill skiing and snowboarding, like many other sports, contains inherent risks including, but not limited to the risk of personal injury, including catastrophic injury, or death, or property damage, which may be caused by variations in terrain or weather conditions; or, surface or subsurface snow, ice, bare spots or areas of thin cover, moguls, ruts, bumps; or other persons using the facilities; or, rocks, forest growth, debris,

branches, trees, roots, stumps; or, other natural objects or manmade in skiing. If you are not willing to assume all of these risks and abide by objects that are incidental to the provision or maintenance of a ski

Notes, Terms And Conditions

- 1. Group Program Rates apply only when purchased through a Song Mountain or Labrador Mountain authorized Group Program Advisor.
- 2. 1-Day-Per-Week Group Program Passes are good on their respective day at their respective mountain. They are not interchangeable between Song and Labrador. Group Program Advisors may request to move their group to the alternate Mountain on a limited, space available basis.
- 3. Unrestricted 'Full Season Passes' are good any time, any day at both Song and Labrador. <u>NO LESSONS ARE</u> INCLUDED. To add the 6 week lesson program add \$50 EACH (see note 8). These passes are also eligible for Okemo Mountain lift ticket perks. See SkiCNY. com for details on our Okemo partnership.
- 4. Lessons run for six consecutive weeks on your chosen day of the week starting January 2, 2018. No "makeups" will be given for missed lessons.
- 5. A per diem group rental rate is NOT available until the completion of the 6 week program and upon presentation of an expired "Group Rental 6 Pac".
- 6. A \$6 rental "Damage Waiver" is included and insures

against any damages to rental equipment. It does NOT cover loss or theft!

- 7. All individual payments must be made to your Group's Advisor, per their instructions. All group payments must be made in total by the Group Program Advisor on or before December 1, 2017. There is a 12% surcharge for any payments made after December 1, 2017.
- 8. Full Season Passes do not include lessons. To participate in the 6 week lesson program when purchasing a Full Season Pass, add \$50 EACH.
- 9. Lockers are sold on a first come, first served basis. Varying widths are available but all are 72" tall. 12" wide = \$125, 15" wide = \$150, 18" wide = \$175. For skis longer than 190 cm, add \$50 for a slope topped locker.
- 10. A contribution to the "Ski Patrol Endowment Fund" is 100% VOLUNTARY. Any amount will be accepted but \$10 for individuals and \$20 for families is suggested. All funds collected go to update Ski Patrol equipment enhancing their ability to serve the skiing and snowboarding public. Song Mountain or Labrador Mountain do not retain any of these contributions.

Season passes must be worn above the waist so that they remain easily visible at all times. The operation of Song & Labrador Mountains are at the sole discretion of management and may be dictated by weather, snow conditions, safety concerns, and many other uncontrollable variables. Lost or stolen passes should be reported immediately. There is a \$25 charge for replacement of lost or stolen passes. Do not forget vour pass! Day lift tickets will be issued in lieu of forgotten passes as follows: first time = \$5, 2nd time = \$25, 3rd time or more = full ticket price. Passes remain the property of Song & Labrador Mountains and are strictly nontransferable. Passes will be revoked without refund if transferred or otherwise misused.

NO REFUNDS for season passes will be issued FOR ANY REASON.
